This agreement is made between Pine Street Entertainment LLC., dba KC Arena Bounce, and the above stated client (hereinafter "Client").

Deposit is non-refundable. Cancellations can be made up to 30 days prior to your event with loss of deposit. Final payment to be made two weeks prior to event. In the case of outdoors events canceled or rescheduled due to precipitation or high winds, the deposit can be applied to an alternate date

Pine Street Entertainment LLC agrees to provide Client, throughout duration of specified time period of contract, the following: Delivery, set up and tear down of the Astrobball Arena.

Client agrees to: (1) provide roughly 50x30 ft space within which Pine Street Entertainment LLC will operate, (2) provide 2 separate 110 volt electrical outlets with minimum 15 amp service for Pine Street Entertainment LLC usage during event within 50 ft of operating space, and (3) be held responsible for any damages to equipment by client or any of client's guests

Pine Street Entertainment LLC agrees to: (1) Provide a fully operational inflatable arena within the rental agreement for no additional charge or fee. Pine Street Entertainment, LLC. will seek to fulfill the full duration of time contracted herein even in the event of delays/interruptions. (2) Coordinate set-up & removal of the inflatable arena within designated time frame.

Other agreements: (1) In the event of a mechanical failure or, if for any other reason Pine Street Entertainment LLC is unable to operate during part or all of the time contracted, the amount charged will be prorated accordingly. The maximum liability held by Pine Street Entertainment LLC is to be the return of any payments received.

Pine Street Entertainment LLC will not be held liable under any contract, negligence, strict liability, or other theory for direct, indirect, incidental, or consequential damages (including without limitation, damages for lost profits or increased expenses) with respect to any claim arising from or related in any way to this agreement, the subject matter of this agreement, the services provided under this agreement, or the property where these services are being performed. (2) Pine Street Entertainment LLC retains the Rights to all photos taken, and may post them on our website, blog, advertising, social media, etc. (3) Client & Pine Street Entertainment LLC agree that client shall procure, at their expense, adequate general liability insurance naming Pine Street Entertainment LLC & it's attendance as additional insured against any & all claims for bodily injury & property damage occurring in, or arising out of Pine Street Entertainment LLC's performance of this agreement. Client agrees to indemnify & hold Pine Street Entertainment LLC harmless from all losses &/or damages incurred as a result of client's failure to procure adequate insurance pursuant to this provision. (4) This agreement constitutes the entire agreement between Pine Street Entertainment LLC & client with respect to the subject matter & performance of this agreement & supersedes all prior & contemporaneous oral, written & other agreements between the parties with respect to the subject matter hereof . This contract may only be amended in writing signed by Pine Street Entertainment LLC & client.

WAIVER OF LIABILITY: CUSTOMER hereby agrees to everything stated above.

CUSTOMER also agrees to exempt, release, and hold harmless Pine Street Entertainment LLC from any claims, actions, suits, costs, damages or liabilities including but not limited to liability for personal injury of any person at the event, property damage, and/or wrongful death, including if caused by negligence on the part of Pine Street Entertainment LLC or any of its agents, owners and/or employees.
