

## **ASTROBALL ARENA PARTY SAFETY RULES & LIABILITY RELEASE**

**Please take a moment to read through the following information**

Before every delivery our jumps have been cleaned, disinfected & inspected for safety, and operation.

Your delivery person will set the jump unit up in the location of your choice **ONCE**.

UNLESS THE AREA FOR SET UP IS NOT SAFE.

**No checks are accepted unless prior arrangements have been made. \$25 CHARGE FOR ALL CHECK RETURNED.**

**ATTENDANT: The Jump is NOT a babysitter. We require that an attendant be present at ALL TIMES. Safety is a primary concern. Accidents will happen without close adult supervision. We can provide an attendant for an additional fee with a 5 day notice of your event time.**

**JUMP & GAME SAFETY RULES:** Be sure to carefully read and follow these Mandatory safety rules.

**PLEASE EMPTY YOUR POCKETS.**

**NO SHOES - ONLY SOCKS OR BARE FEET AT ANY TIME. NO CLIMBING ON THE WALLS OR NETTING.**

**DO NOT USE JUMPER IF YOU ARE PREGNANT OR HAVE NECK, BACK OR KNEE INJURIES.**

**FLIPPING IS NOT PERMITTED AT ANY TIME... SERIOUS INJURIES CAN OCCUR.**

**DO NOT SLIDE HEAD FIRST!**

**NO EYE GLASSES, HOOP EARRINGS, OR SHARP OBJECTS.**

**NO FOOD, DRINKS, CANDY, OR GUM ALLOWED INSIDE.**

**NO SILLY STRING, CONFETTI OR WATER IN OR AROUND INFLATABLE AT ANY TIME.**

**KEEP PETS AWAY AT ALL TIMES!**

**ANY DAMAGE WILL BE BILLED FOR FULL REPLACEMENT COST AND LOSS REVENUE.**

**NEVER PUT TOO MANY CHILDREN INSIDE THE INFLATABLE AT ANY ONE TIME**

**CAPACITY:** These are estimates, depending on the size of the kids.

**The Astrobball Arena** will fit up to 18 kids, or 10 adults

**POWER:** The Astrobball Arena requires two blowers (the units that blow up the Aerean). Each blower uses 12 Amps of power. A separate 110volt outlet with a 15 Amp or greater breaker is required for each blower. We cannot place your jump more than 75 feet from the power source.

No other electrical devices can be plugged in to that circuit while the blower is in operation.

**IF THE GAME DEFLATES, CHECK (1) POWER SOURCE, (2) SUPPLY TUBE STRAP, (3) BLOWER AIR INTAKE. DEFLATE THE JUMPER IF WINDS SPEED EXCEEDS 15 MPH. PLEASE CONTACT US FOR ANY ASSISTANCE.**

For sites where electrical power is **not** be available, we can supply you with a generator at an additional charge.

Generators come with a 5 Hr supply of Gasoline. We must be notified a minimum of 5 days prior to the event if a generator is needed.

**CONDITIONS OF USE:** Lessee agrees that rented equipment: **Shall not be subject to unnecessary rough usage.** \* Shall not be used for illegal purposes. \* Shall not be sublet or assigned. \* Lessee shall abide by all rules and regulations as contained herein. \* Lessee shall not remove or alter any nameplate or other form of identification showing ownership of rented equipment. **Lessee shall not move or relocate the game unit in any way whatsoever.** \*\*

**INDEMNIFICATIONS:** LESSEE AGREES TO INDEMNIFY LESSOR AND HOLD LESSOR HARMLESS FROM ANY AND ALL CLAIMS, ACTIONS, SUITS, PROCEEDINGS, COST, EXPENSES, DAMAGES AND LIABILITY, INCLUDING ATTORNEY'S FEES, FINES, AND PENALTIES ARISING OUT OF, CONNECTED WITH, OR RESULTING FROM, THE EQUIPMENT OR ITS USE, OR THE PERSONNEL PROVIDED, INCLUDING WITHOUT LIMITATION, THE MANUFACTURE, SELECTION, POSSESSION, USE, OPERATION, CONDUCT, OR RETURN OF SAID EQUIPMENT. PINE STREET ENTERTAINMENT LLC dba KC Arena Bounce AND ASTROBALL PARTY INC ARE NOT RESPONSIBLE FOR ANY DAMAGE TO YOUR GRASS AND PLANTS WHERE THE JUMP IS SETUP. LESSEE AGREES TO PAY LESSOR THE FULL LIST PRICE AND/OR ESTIMATED COST OF REPAIRS FOR ANY AND ALL DAMAGES TO RENTED EQUIPMENT RETURNED IN A DAMAGED OR NON-OPERATIONAL CONDITION. ITEMS THAT GET WET WILL OCCUR A \$50 CLEANING FEE (AS DETERMINED BY LESSOR). LESSEE AGREES TO RETURN RENTED EQUIPMENT IN THE SAME CONDITION AS IT WAS RECEIVED

**LESSEE MUST REMAIN WITH THE RENTED EQUIPMENT AT ALL TIMES.**

THIS AGREEMENT ENCOMPASSES THE ENTIRE AGREEMENT BETWEEN THE LESSOR AND THE LESSEE AND ANY CHANGES MUST BE IN WRITING. LESSEE AGREES TO PAY ALL ATTORNEY'S FEES, COURT COSTS, NON-SUFFICIENT FUNDS CHARGES, AND ANY COST OF COLLECTION THAT LESSOR MAY INCUR.

PAST DUE ACCOUNTS WILL BE CHARGED INTEREST CHARGE LATE FEE AT THE RATE OF 25% PER MONTH.
